John Wesley still rides his horse in the Broadmead Courtyard, but Charles Wesley is undergoing some restoration work while in temporary storage during the construction phase of the Horsefair Project. We look forward to his return.

We are immensely grateful to the Bristol District for the generous grant which provided the bulk of the match funding for our Heritage Lottery Fund award, and to the trusts, Local Churches and individuals who have given financial support. Work on the new building commenced at the start of January 2016 with the removal of the old, ugly outbuildings and the driving in of 28 nine metre deep piles. This is a much more robust physical foundation than that of the adjoining Grade I listed building, but the spiritual roots of the New Room remains the real foundation for all we are seeking to do. Whilst it is exciting to see the progress of the new building - and we are on track for a grand opening in June 2017 - what is even better is seeing the growth in outreach that is already taking place as a result of the Project.

As part of our growing educational programme, we had contact with just under 1,700 pupils during the academic year 2015/16 who visited the New Room or took part in a workshop or assembly at their school. A group of six creative media production students are using photography and video to make a record of the construction project on a weekly basis. Half-term "Where's Wesley" family days successfully road-tested our new family activity guidebook. Education Officer Mandy Briggs has also worked with five primary schools, museum design company 'Cod Steaks' and Biggerhouse Film to create an animated/live action film based on 'John Wesley's Manifesto', written by Warden Gary Best. This has been a really exciting project! After a school choir records the soundtrack at the end of June, the film will be ready to show to the public.

In October 2015 the New Room was closed to the public for a week while an episode of "Poldark" was filmed in the chapel. Charles Wesley's House was used as a filming location for a BBC documentary about Thomas Chatterton that featured the Queen guitarist, Brian May, and in April 2016, the chapel hosted a Bristol Old Vic Theatre School production of 'Frankenstein'.

Visitor numbers are slightly down. This can be attributed to the cessation of the Saturday coffee mornings and, since January, the closure of access from the Horsefair. We again hosted "Cards for Good Causes" in the run up to Christmas and a new initiative was an extensive Fair Trade 'pop up' shop in the chapel during Fair Trade Fortnight. Christmas in the Courtyard and Carols by Candlelight were again featured. A number of exhibitions have taken place within the Chapel - one of the most notable being a display of drawing by Syrian children refugees. The central location of the New Room makes the building ideal for that kind of event.

The latest recruit to the staff is Lucie Connors, our Community Engagement Officer. She is networking with a wide range of organisations across the city, with the aim of developing a wider range of visiting groups and of volunteers. Experienced teams of people are already working on the museum collection, the archives, and the library in preparation for the move into the new building.

The Warden, Gary Best, is channeling his historical and educational expertise into the development with Bristol-based Cod Steaks of a dynamic and interactive new museum that will engage people of

all ages and backgrounds in the story of the Wesleys and their relevance for today. He is also writing a range of new studies, including biographies of John Cennick and Grace Murray and the first ever History of the New Room.

We are delighted that, despite the disruption caused by building work, we have managed to keep the Chapel and Preachers' Rooms open to visitors, relying on our faithful band of stewards. Friday lunchtime Communion Services have continued to attract a loyal attendance, and the fortnightly half-hour concerts following on often feature the Snetzler organ. Samuel Wesley, son of Charles, nicknamed "the English Mozart" is being featured this year as 2016 is the 250th anniversary of his birth. We are re-publishing Samuel Wesley's book of 38 hymn-tunes, with suggestions as to which words they might be sung to. The New Room also has a special interest in Francis Asbury. The Stewards enjoyed their outing to the Black Country Living Museum in April and there will be a "Pilgrimage to Pill" from the New Room in September marking Asbury's departure to America. This is part of a wider programme of events planned over a weekend with local circuits in Bristol to commemorate Asbury 200.

This year **Clare Campion-Smith** resigns as a trustee. A faithful Methodist, she has also been our advocate on the City Council. **Constance Gould,** who has performed the tricky task of making the Stewards' Rota for many years is also resigning, and will be greatly missed.
